VU TF student Emilija Valentinaitytė continued her journey in the international project Law Without Walls (LWOV) even during the global pandemic and successfully presented a prototype of solving the legal problem she had with the team white & case 1 in the LWOV Composite a week ago.



Emilia, tell us about your team's task, how was the solution sought?

My team's theme was "How can law firms work with clients to identify and enhance the value of their relationships with external legal and professional advisors?" While the topic may not seem complicated at first glance, we have faced a number of challenges to properly analyze it.

Throughout the project, our main source of knowledge was interviews with professionals in various fields - both law firm partners or client relationship managers, and law firm clients themselves. The insights from all of them were helpful, but it was clear that everyone sees different aspects of this problem that we had to refine in order to find the most appropriate solution.

Interesting! What will you bring from this project and what impressions would you like to share with the students now reading this news?

LWOV provided an opportunity to meet and learn from renowned law firm and global corporate representatives. It gave me invaluable knowledge about innovative solutions to real problems and the development of business ideas and start-ups. This experience can certainly be applied in practice, and the knowledge gained is necessary for every lawyer, both a newcomer to the legal profession and a skilled lawyer. 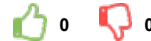
